Applications-

In the last two months, the AEDY Program Provider applications were returned. If your program needed to revise and resubmit, please log onto PDE's online AEDY system at https://apps.leaderservices.com/ aedy/index.aspx. The AEDY Program is responsible to update and resubmit the application through the online system within the specified number of calendar days indicated on the notice for The AEDY Team's review. Final applications for all must be submitted no later than indicated on the letter.

Updates:

Model Complaint-

- 1. Remove line #1 that states "a statement that * has violated any applicable federal and/or state law or regulations".
- 2. Remove the #5 "the signature" and the signature line at the end of the document.
- 3. Where the document identifies the AEDY program <u>and</u> the LEA will work together to resolve the complainants concerns. In each instance, the document should reflect AEDY program "and" LEA.

English Learners-

All English Language Learners ("ELs") are entitled to equal access to the general education curriculum via modifications or adaptations and/or special accommodations to instruction and assessments, as well as to planned instruction in English language development.

An LEA who sends a student who is EL to an AEDY program is responsible to outline and provide an EL Service Plan and an individualized plan to meet the goals of the student within the AEDY program. The sending LEA will upload the EL plan, and identify other required questions as they relate to students who are English Learners.

Programs that receive students who are EL need to detail how they will implement the individualized EL Plan within the context of the student's AEDY program. The referral requests of the sending LEA and the AEDY program to identify who will provide the EL supports.

For Referring LEA's-

Referrals to AEDY Programs are to be completed using the online system at https://apps.leaderservices.com/ aedy/index.aspx. The placing LEA and the AEDY program are to communicate to enter the required student data towards submission. All referrals, including the students who carried over from last school year into this school year, must be entered into the system.
